# Function of the Work Health and Safety Advisory Council

The Work Health and Safety Advisory Council (WHSAC, the Council) is established under the Work Health and Safety (National Uniform Legislation) Act 2011 (the Act) to carry out the following functions in accordance with schedule 2(3) of the Act:

- Keep under review the operation of the Act.
- Make recommendations to the Minister on possible changes to the administration of the Act or standards of work health and safety in the Northern Territory.
- At the Minister request, investigate and report on matters relating to work health and safety.
- Perform any other advisory functions relating to work health and safety as the Minister directs.

## Meetings of the Work Health and Safety Advisory Council

In accordance with schedule 2(9) of the Act, WHSAC must meet when directed by the Minister to do so, and at any other time the WHSAC chair considers appropriate.

## Membership of the Work Health and Safety Advisory Council

In accordance with schedule 2(4) of the Act, the Council membership consists of:

- The Work Health Authority.
- Not more than 10 other persons appointed by the Minister, which includes:
  - Persons with a wide range of experience extending as far as possible across all major industry sectors in the Territory, and
  - As far as is practicable, consists of equal numbers of representatives of organisations representing employees.

### **Current Work Health and Safety Advisory Council Members**

On 24 June 2020 the Minister appointed the following WHSAC members consisting of the following membership for a term which expires on 24 June 2022.

#### Mr William Esteves -NT WorkSafe - Work Health Authority

#### (Appointed 18 June 2020)

Mr Esteves is the person constituting the Work Health Authority. Mr Esteves is also the Executive Director of NT WorkSafe, the Electricity Safety Regulator and the Chief Inspector *under the Radioactive Ores and Concentrates (Packaging and Transport) Act 1980*, the Northern Territory member of Safe Work Australia, and the Heads of Workplace Safety Authorities.

#### Ms Andrea Moriarty, Construction Industry - Chair

#### (Appointed 24 June 2020)

Ms Moriarty is a Director of Kalo Real Estate and the current Vice President of the Master Builders Association NT. Ms Moriarty has been involved with residential construction for the

# Planned Activities of the Work Health and Safety Advisory Council for 2021-2022

Proposed work to be undertaken by the WHSAC in 2021-2022 include:

- Continuing to consider and action three recommendations from the Best Practice Review of Work Health and Safety in the NT referred to the Council:
  - NT WorkSafe develop a more effective system to ensure that the families of victims of fatalities are supported, modelled on best practice used by police services.
  - The Work Health and Safety Advisory Council monitor trends in relation to prosecutions in relation to the number of proceedings, success rate and penalties awarded.
  - NT WorkSafe develop a comprehensive plan to support health and safety representatives and health and safety committees, an encourage uptake in industry, particularly within priority industry sectors.
