

# Automatic mutual recognition notification

## - Gasfitter or Shotfirer

Use this form to notify of your intent to work under automatic deemed mutual recognition (AMR) as a shotfirer or gasfitter in the Northern Territory under Part 3A of the [Mutual Recognition Act 1992](#).

Individuals who hold a current licence in another state or territory are able to apply for AMR in the Northern Territory (NT) without needing to pay additional fees or apply for a separate registration.

While working in the NT, you are required to comply with the *Dangerous Goods Act 1998* and *Dangerous Goods Regulations 1985*, and can only conduct the activities that you are authorised to under your interstate licence or registration.

If you intend to change your primary place of residence to the NT, you will be required to apply for a NT licence. Fees may apply for this process.

**Note:** Companies are unable to apply for AMR.

I, solemnly and sincerely declare that:
